Si ocurre algo inesperado y necesito un tratamiento adicional o diferente del que espero, acuerdo aceptar cualquier tratamiento que resulte necesario.

Acepto recibir transfusiones de sangre y otros hemoderivados que puedan ser necesarios junto con el procedimiento que me están realizando. Me han explicado los riesgos, beneficios y alternativas y me han respondido todas las preguntas a mi entera satisfacción.

Si me niego a recibir transfusiones voy a tachar y colocar mis iniciales en esta sección y firmar un formulario de RECHAZO DE TRATAMIENTO.

Acuerdo permitir a este centro conservar, usar o desechar adecuadamente tejidos y partes de órganos que me extirpen durante este procedimiento.

I explained the risks, benefits, side effects and alternatives of the Central Venous Catheter (Identify Procedure) to the above-named patient for treatment of _____ (Identify Diagnosis).

As I explained to the patient, the risks, benefits, side effects, alternatives, intended goals and likelihood of success of the procedure to achieving health care goals (including potential problems with recuperation) include but are not limited to:

Risks and side effects of the proposed care: -Arterial puncture/Arterial dilation - Bleeding -Hematoma Formation
-Pneumothorax -Air Embolus - Wire Migration -Pneumothorax - Thrombosis
-Arrhythmia -Catheter Infection

Benefits: -Ability to administer vasopressor medications that cannot be safely administered through long periods via a peripheral catheter -Blood draws -Ability to administer several medications through one catheter

Alternatives (including their risks, side effects and benefits): -Peripheral venous catheters - while this avoids several risks listed above, it is not safe to administer vasopressor medications through these for long periods

Risks related to not receiving the procedure: -Worsening of condition -Worsening shock

I provided the above-named patient with the opportunity to ask questions. I have answered the questions asked and it is my professional opinion that the patient understands what I have explained.
